

Supplier Business Ethics Policy 供应商商业道德守则

Dear Supplier Management,

致供应商代表,

Chiaphua Components Group have implemented a strict 'Code of Business Conduct' for Chiaphua Components employees in which prohibit the acceptance of gifts, cash, red-pocket money, advantage of any kind. This letter of Business Ethics Policy is presented to all suppliers' management to explain the expectations we have for Chiaphua Components employees as well as your employees during our business activities. We kindly ask that you read it, understand it, sign it, and follow it:

捷和电机集团 执行严格的「员工职业操守行为准则」,决不允许捷和电机员工收取供应商礼物,现金,红包等任何形式的利益。我们特向所有供应商传达此份"供应商商业道德守则",以明确我们与供应商业务往来过程中对捷和电机员工和供应商人员的期望和要求。我们希望您们认真阅读,理解,签署并且遵从这份准则。

- 1. This letter is to explain the <u>Business Ethics Policy</u> on all personal advantages offered by any of our suppliers. The term "advantage" means any (or the promise of any) gift, loan, fee (e.g. promotion fees, public relation fees, scientific research fees and consultant fees), reward (e.g. domestic or overseas trip, and entertainment), bribe, kickback, gratuity, advances, commission, sponsorship, employment, service, favor, investment benefits, free or substantial below market rent lease of any kind (e.g. house, car etc.) or education/ housing arrangement for children and spouse.
 - 本守则解释了<u>商业道德守则</u>中我们对任何供应商提供的任何个人利益的定义。"利益"是指任何礼物、贷款、费用(包括促销费、公共关系费、科研费与咨询费)、奖励(包括国内外旅游、娱乐活动)、贿赂、回扣、佣金、垫付款、劳务费、赞助、雇佣关系、服务、优惠、投资得益、免费或大幅低于任何种类的市场租赁租约(例如房屋,汽车等)或给子女和配偶的教育/住房安排。
- 2. Any form of personal advantage offering or receiving (no matter active or passive) is forbidden. 任何形式的个人利益给予或接受(无论主动或被动)都是不允许的。
 - (1) Personal advantage requests: All suppliers never, under any circumstances, give in to demands or requests for personal advantage or payments from any Chiaphua Components employee or their designated recipients. If any Chiaphua Components employee or their designated recipients requests or solicits for any direct or indirect payment or personal advantage mentioned above, we expect you to contact us immediately.

员工索取利益: 所有供應商在任何情况下都不可屈从于捷和电机员工或其指定的领受者有关个人利益或金钱方面的索求。如果捷和电机员工或其指定的领受者索取任何直接或间接的个人利益或金钱, 我们希望您们立刻跟我们联系。

(2) Personal advantage offers: All suppliers never, under any circumstances, offer any red pocket, gift or other personal advantage mentioned above to any Chiaphua Components employee or their designated recipients. Any personal advantage given or offered to any Chiaphua Components employee or their designated recipients will be considered as a corrupt practice and violate this Business Ethics Policy.

供应商给付个人利益: 所有供應商在任何情况下厂方都不可给付红包, 礼物或其他个人利益给捷和 电机员工或其指定的领受者。对捷和电机员工或其指定的领受者给付任何个人利益都将被认定是贿赂 行为,违反了此商业道德守则。

- 4. In addition to the rights under agreements between Chiaphua Components Group and suppliers, if we find that suppliers fail to comply with the requirements or violate the provisions of "Supplier Business Ethics Policy" or their conduct is inconsistent with the intent of the "Supplier Business Ethics Policy", Chiaphua Components Group retains the ultimate and sole right to take the following measures:

除了捷和集团与供应商达成的协议条款的权利外,如果供应商不能遵守《供应商商业道德守则》或捷和集团发现供应商违背了《供应商商业道德守则》条款或其行为不与《供应商商业道德守则》意图一致, 捷和集团保留权利采取下列措施:

- (1) To terminate commercial relations with suppliers, including cancel the outstanding orders, or 终止与供应商的商业关系,包括取消未完成订单,或.
- (2) To terminate contract without any compensation and contractual liabilities, or 在无任何补偿和合同责任下终止合同, 或.
- (3) Take corrective actions and/or work with the supplier to develop and acceptable corrective plan to continue or restore business relations within the acceptable period, or 在可接受时期内, 采取纠正措施和/与供应商一起制定可接受的纠正计划,以继续或恢复商务关系, 或.
- (4) Report to the responsible bureau for criminal investigation on serious cases. 向执法机构举报有关罪行个案。
- 5. This Supplier Business Ethics Policy is legally binding. 此份「供应商商业道德守则」具有法律约束力。
